

PALM OIL GRIEVANCE LOG

Introduction

PepsiCo has established a grievance tracker in line with our Global Policy on Sustainable Palm Oil Implementation Plan to assist in transparently monitoring stakeholder complaints submitted through our grievance mechanisms.

This tracker provides visibility into complaints raised directly to PepsiCo concerning potential social and environmental issues that may have arisen within PepsiCo's palm oil supply chain since 2023. These complaints are submitted directly to PepsiCo and allege potential non-compliances with PepsiCo's Global Policy on Sustainable Palm Oil or Global Supplier Code of Conduct.

Through PepsiCo's membership in the Roundtable on Sustainable Palm Oil (RSPO), we recognize the RSPO's Complaints System and will consider, but not be bound by, RSPO's process and decisions as part of our own grievance procedure.

This tracker should be viewed in the context of our broader efforts on palm oil sourcing. Updates to this tracker are published regularly on our website. The tracker represents the status of the listed complaints to the best of our knowledge as of the date of publication.

Given the complexity of global supply chains, updates to PepsiCo's public supplier and/or mill lists may take up to 12 months to reflect the addition of a particular supplier to a suspension list. PepsiCo reserves the right to continue sourcing from suppliers named in grievances, based on our independent assessment and engagement.
